## Nomination Procedure

A student's home institution's exchange coordinator should send a formal exchange nomination by our deadline.

We will email the online nomination form to coordinators in the early spring.

The online nomination form requires the students' name, citizenship, gender, birthdate, university email address, and secondary email address.

## Application Procedure

Once the home institution nominates a student, Collier's Incoming Coordinator will reach out and ask the student to complete our Exchange Application.

Required documents for students from partner schools:

- Transcripts/record of studies
- CV
- Passport photo
- English certification, if needed (see below regarding English Requirements)

Required documents for Free Movers (from non-partner schools)

- Transcripts/record of past and current studies
- CV
- Home institution's approval
- Passport Photo
- English Certification (more information under English Requirements)

## English Requirements

All courses in the Collier Exchange Program are taught in English. Therefore, a high level of English Proficiency is required. If your home school is not affiliated with PIM we require one of the following:

- TOEFL: a minimum of 100 on the internet-based test and 250 on the computer based test
- IELTS: a minimum of 7
- Students who completed their undergraduate studies in English or are currently studying their entire graduate degree in English can submit a letter from their home university confirming English proficiency in lieu of an English proficiency exam
- An official letter from an English expert at the home university that confirms the English level is B2 or above



## Dates for 2024-25

Exchange for undergraduate students is a full semester (13 weeks) for both fall and spring semesters.

Graduate students can attend the exchange program for the full semester (14 weeks) in the fall, or choose either the first half or the second half of the first semester. Graduate exchange courses are only offered in the first half of the spring semester.

## Summer Program 2024

### Dates TBD

The summer program for graduate students consists of short (week-long) intensive courses throughout the summer. The exchange ratio is usually 3:1.

## Academics

The Coller School of Management offers a wide variety of courses in many fields of management and business, including strategy, operations, leadership, HR, Marketing. Many of the exchange courses emphasize innovation, technology and entrepreneurship.

---

## Course Load

### Undergraduates students:

- Full semester - 13 weeks
  - Must take at least 10 university credits (20 ECTS)
- A two-credit course is the equivalent of 13 meetings of one and a half hours

### Graduate students

- Full semester - 14 weeks
  - Must take at least 5 Coller credits (20 ECTS)
- Half semesters - 7 weeks
  - Must take at least 3 Coller credits (12 ECTS)
- A one-credit Coller graduate course is the equivalent of seven meetings of two hours and 45 minutes. Two credit courses are 14 meetings.

2 undergraduate credits = one graduate credit = 4 ECTS

---

## Learning Expectations

Most courses combine frontal lectures with case studies and teamwork. The evaluation of class participation and attendance differs from class to class and is at the lecturer's discretion.

## Grading

The TAU grading system is based on scores of 0-100:

95-100=Excellent

85-94=Very Good

75-84=Good

65--74=Fairly Good

60-64= Fair

0-60=Fail

We will send transcripts by e-mail to both the home institution and the students after the end of the exam period.

---

## Exams

Exam period is held for the three weeks following the end of each semester. We try to schedule all exams for exchange courses during the first week of exams.



## Housing

On-Campus housing is offered on a limited basis, but cannot be guaranteed. Students should seek housing as soon as possible. The Exchange Coordinator will provide students with information on housing options around the city.

Off-campus housing is about 800-1000 USD per month (for a room in a shared rented apartment).

## Expenses

Academic expenses: 100 USD per term

Living expenses: 1,000 USD per month (transportation, food, pastime, etc.)

Student activities: 100 USD (optional)

Sport Center membership ~400 USD per semester (optional).

---

## Health Insurance

Exchange students must have health insurance either from their home country or preferably from an Israeli company. Tel Aviv University offers health insurance through an Israeli provider. The estimated cost is 2.5 USD per day.

Each student must provide health insurance coverage documents prior to arrival.

---

## Student Visa

The letter of acceptance that will be issued by the Coller Exchange Coordinator may be used to obtain a student visa. Students should secure a student visa before arriving in Israel.
